Are you in favor of amending the Temple Zoning Ordinance, as proposed by the Planning Board, as follows: To amend **Article IV: General Provisions, Section 17: Signs**, as follows:

Delete existing paragraph (e), as follows:

**SAMPLE**

(e) No neon, flashing or internally illuminated signs, nor signs with rotating or moving to get attention, are permitted.

**Insert** new paragraph (e), as follows:

*(e) No external signs using neon, flashing lights, internal illumination, or rotating or moving components are permitted. A business may have one internally lit sign that does not move, rotate, or flash, with the sole word "OPEN", provided that sign is no larger than 1 square foot and is mounted internally within a window of the business' building.*
