2015 Warrant: The Board reviewed the 2015 money warrant articles for recommendations.

Warrant article #4: Purchase of a new loader for the Highway Department the Board voted to recommend Cromwell and Kieley – yes, Willard – no, on recommendation. Willard voted against recommendation stating that he felt the Board had not been given enough information.

Warrant article #5: Purchase new computers and software for the municipal offices. The Board voted unanimously to recommend.

Warrant article #7: 39% cost of a new police cruiser. The Board voted unanimously to recommend.
